I. Announcements

A. The 2019 SSPP meeting in Cincinnati

The Southern Society for Philosophy and Psychology will meet at the Cincinnati Netherland Plaza Hotel from March 7 through March 9, 2019. The convention room rate is \$175.00, plus 17.50% tax. Valet parking is \$28, nearby self-park is \$20. Program sessions will begin at noon on Thursday, March 7 and will end Saturday afternoon, March 9.

The Cincinnati Netherland Plaza Hotel is located at 35 West Fifth Street, Cincinnati, OH 45202-2899. Open since 1931, it is in the heart of downtown Cincinnati and is considered a National Historic Landmark hotel. The deadline for making room reservations is **February 13, 2019**. It is understood that individuals will make their own reservations either directly with the hotel Reservations Department (24 hour toll-free reservations:

Members should state that they will be attending the meeting of the Southern Society for Philosophy and Psychology, and should request the convention rate. Please make reservations early because the Society is obligated to occupy a block of guest rooms in order to avoid charges to the Society. The Wednesday night room block often is oversubscribed, but if the room block is filled early, the Society may be able to obtain an increase in the room block.

The main airport Cincinnati/Northern Kentucky International Airport is 12 miles from the hotel. There is an airport "Super Shuttle" that leaves every 15-30 minutes from outside the baggage claim area at the airport. Shuttle will make several hotel drop offs. Cost is \$24.00 one way. II. Calls for Papers

A. Richard M. Griffith Awards

This is the first call for papers for the Richard M. Griffith Memorial Awards. Two cash awards of \$300 each plus engraved paperweights will be made for the papers of greatest excellence, one in philosophy and one in psychology, presented at the annual conference in 2018. The awards are presented at the business meeting that concludes the conference. The rules for this competition state that applicants must either have received their Ph.D. no more than five years prior to the date of the annual meeting at which the paper is presented or must be current candidates for the Ph.D. Applicants must be sole or first author of the submission, be present at the meeting to deliver the paper, and not have previously won the award. All Griffith Award applicants must

be either SSPP members or applicants for membership and must indicate their eligibility and whether they are submitting for the philosophy or psychology award when they submit their papers.

B. Graduate Student Travel Grants

Up to six travel grants (up to three in philosophy and up to three in psychology) will be awarded to graduate students whose papers are accepted for the 2018 program. Students can apply for these grants simply by indicating their eligibility on their SSPP submission form. To be eligible for a travel grant, the applicant must be a member or applicant for membership in SSPP and a graduate student in a doctoral program in philosophy or psychology. Applicants may be either the sole or joint authors of the paper or abstract they submit. The travel grants will be awarded on a competitive basis by the Program Committee of each discipline, whose chair will notify recipients at the same time they are sent their acceptance notices for the program.

C. Meeting Registration and Dues

Registration for the 2019 annual meeting will be \$125. This amount includes the \$35 yearly dues for 2018 membership, and so those paying at this level will be considered members in good standing for 2019. Student registration will be \$65, although a limited number of students can volunteer to work at the registration table during the meeting for a waiver of that fee. SSPP Call for Submissions

PHILOSOPHY:

The Southern Society for Philosophy and Psychology announces a call for submissions for its One Hundred and Eleventh Annual Meeting to be held in Cincinnati, OH from March 7 through March 9, 2019. SSPP meetings feature concurrent programs in Philosophy and Psychology, as well as plenary sessions jointly sponsored by the Philosophy and Psychology Program Committees. **The deadline for all philosophy submissions is November 1, 2018.**

The Philosophy Program Committee encourages the submission of single-authored papers as well as symposium proposals. Selection will be based on quality, relevance to issues at the intersection of Philosophy and Psychology (as well as other sciences of the mind), and program considerations. The aim of the program committee is to present a program that is as balanced as the quality of submissions in each area will allow (though papers addressing issues of gender, race, sexuality, bias, and social exclusion are especially encouraged).

Paper submissions exceeding 3,000 words will not be considered. Each paper submission must include a word count and abstract of no more than 150 words. Self-reference should be deleted to permit anonymous review. Proposals for symposia must include a 750 word proposal for the symposium, a list of presenters and affiliations, and a 300 word abstract for each proposed paper. All papers and proposal must employ gender-neutral language.

All submissions must be made through the designated SSPP website, <https://www.southernsociety.org/submission>. Those submitting should indicate whether the author wishes to be considered for a Graduate Student Travel Award or the Griffith Prize.

PSYCHOLOGY:

The Southern Society for Philosophy and Psychology announces a call for abstracts in psychology for its One Hundred and Eleventh Annual Meeting to be held in Cincinnati, OH from March 7 through March 9, 2019. SSPP meetings feature concurrent programs in philosophy and psychology, as well as joint sessions. **The deadline for all psychology submissions is November 1, 2018.**

The Psychology Program Committee encourages submissions in all areas of psychology. All abstracts submitted and presented should employ gender-inclusive language. Titles should clearly indicate the topic of the paper. Contributions for reporting empirical studies must be based on methods appropriate to psychology as a natural or social science. The context, contribution, and importance of the research as well as the hypothesis or question being investigated should be stated clearly. The principal variables and the research design should also be specified. All abstracts should be no more than 300 words.

Submissions of symposia, panel discussions, research posters, and debates are encouraged. In particular, sessions are encouraged that include participation by psychologists and philosophers or that focus on topics of interdisciplinary interest. For symposia or sessions, the organizer should prepare a session abstract, not to exceed two pages, describing the session or symposium theme, content, and importance. All symposium materials should be submitted together and include 'SYMPOSIUM' as a keyword. Research poster submissions should be 300 word abstracts and are open to both graduate and undergraduate students.

The Southern Society for Philosophy and Psychology has approximately 600 members consisting of both philosophers and psychologists. The purpose of the society is to promote philosophy and psychology in the southern section of the United States by encouraging new research, facilitating the exchange of ideas, fostering the educational foundation of philosophy and psychology, and improving the academic status of these subjects.

The primary activities of the society are its annual conferences. These annual meetings consist of concurrent programs in philosophy and psychology as well as joint, plenary sessions of mutual interest to philosophers and psychologists. Each annual meeting features a distinguished speaker invited by the President, alternating between a philosopher and a psychologist. Recent President's Invited Speakers have been Alan Brown (2018), David Chalmers (2017), Thalia Wheatley (2016), Susanna Siegel (2015), Dan Ariely (2014), Susan Schneider (2013), Marcia Johnson (2012), Elliott Sober (2011), and Lisa Feldman Barrett (2010).

Each year the Southern Society for Philosophy and Psychology presents the Richard M. Griffith Memorial Award for papers of greatest excellence, one in philosophy and one in psychology. Members or applicants for membership who have received their Ph.D. during the past five years or who are Ph.D. candidates are eligible to compete for the award. The award carries a \$300 cash prize presented at the business meeting that concludes the annual conference, plus a commemorative paperweight.
